### COURSE SUMMARY

By utilizing validated mobility outcomes for lower limb prosthetic patients, health care teams can empower patients to understand and participate in their own care leading to higher satisfaction. This introductory level course designed for PT/PTA's, OT/OTAs, Nurses and Case Managers teaches on new methodology on collecting outcomes, utilizing the Prosthetic Limb Users Survey of Mobility (PLUS-M) self-reporting instrument. This course ensures the learner understands patient and output research trends, and more specifically, how health care teams can collaborate with physicians and patients alike to improve patient care.
